1 This matter came before the Court on September 18, 2018. This motion is unopposed by
2 Defendants. Having considered the motion papers, the proposed Settlement Agreement which the
3 Court preliminarily approved on May 2, 2018 and has now fully approved, the arguments of
4 counsel, and all files, records, and proceedings in this action, and otherwise being fully informed
5 in the premises as to the facts and the law,

6 IT IS HEREBY ORDERED AND ADJUDGED THAT:

7 1. Class Counsel's request for an award of \$570,000.00 in attorneys' fees is
8 approved. Having reviewed Class Counsel's fee application and all applicable legal authorities,
9 the Court finds the requested amount of fees to be reasonable and appropriate.

10 2. Class Counsel's request for litigation expenses in the amount of \$9,699.02 is
11 approved. The Court has reviewed these expenses and finds that they are reasonable and
12 appropriate.

13 3. Plaintiffs' request for class representative service awards in the amount of \$10,000
14 each to Margaret Tumamos, Jonathon Lai, and Connie Lam is approved. The Court finds these
15 awards to be justified under the facts of this case and consistent with applicable legal authorities.

16 4. The amounts approved in Paragraphs 1, 2, and 3 above shall be disbursed from the
17 Gross Settlement Amount after the Settlement Effective Date, in accordance with Paragraph 4.10
18 of the Settlement Agreement.
