THE DEADLINE FOR SUBMITTING THIS FORM IS DECEMBER 24, 2018.

I have received the notice of settlement in *Slone et al. v. Gulfport Energy Corporation*, Case No. 5:16-cv-01296-HE (W.D. Okla. filed Nov. 14, 2016) (the “Lawsuit”). I voluntarily consent to participate in the settlement and join the Settlement Collective. I submit this claim form and release agreement under the terms of the settlement agreement filed in the Lawsuit.

By signing below, I hereby:

- Agree on behalf of myself and my heirs, descendants, dependents, executors, administrators, successors, and assigns, to fully and finally release and discharge Gulfport Energy Corporation, its prior and present subsidiaries, affiliates, parents, predecessors, successors, representatives, officers, directors, agents, attorneys, accountants, assigns, and employees, in their personal, individual, official, and/or corporate capacities, from any and all claims and rights of any kind that I may have, whether known or unknown, whether contingent or non-contingent, whether specifically asserted or not, which have been pled in the amended complaint in the Lawsuit, or which could have been pled based upon the factual allegations in the amended complaint in the Lawsuit, including claims under the Fair Labor Standards Act (29 U.S.C. § 201 *et seq.*) (“FLSA”), Chapter 4111 of the Ohio Revised Code, or any other local, state, or federal laws, including all wage and hour, common, contract, and tort laws, arising through the date I execute this claim form and release agreement (“Released Claims”). Released Claims include claims based upon or related to any alleged failure to pay overtime for work performed in Ohio, including claims for back pay, penalties, interest, liquidated or other damages, litigation costs, and attorney’s fees;
- Acknowledge that neither Gulfport’s agreement to settle nor my receipt of a settlement payment is an admission of liability or an acknowledgement of any violation of any law;
- Acknowledge that I have had the opportunity to review this claim form and release agreement and that I understand and voluntarily agree to its terms;
- Submit to the jurisdiction of the U.S. District Court for the Western District of Oklahoma (the “Court”) with respect to my claim as a settlement collective member and for purposes of enforcing this release and waiver of claims. The full terms of the settlement are contained in the agreement approved by the Court. I further acknowledge that I am bound by the terms of any judgment entered by the Court in the Lawsuit. I agree to furnish additional information to support my entitlement to a settlement payment if required to do so. If I am the executor, heir, or representative of a settlement collective member, I have provided proper documentation of such status on separate sheets attached; and
- Consent to opt in to the Settlement Collective pursuant to section 16(b) of the FLSA, 29 U.S.C. § 216(b).
